TRILUTION micro License Agreement

All users of Gilson Inc.'s proprietary Software (the "Software") are required to agree to the following terms and conditions unless they previously signed a software license agreement in which case the terms of the previously signed agreement shall prevail. This agreement (the "Agreement") is between you ("Customer") and Gilson, Inc. ("Gilson") for use of the Software by Customer.

1. LICENSES

1.1. Access to the Software

Subject to the terms and conditions of this Agreement, Gilson hereby grants to Customer a limited, non-exclusive and non-transferable right to access and use the Software in accordance with the specific limitations set forth in this Agreement. Customer shall not have any other rights to the Software other than those granted under this Agreement.

Customer agrees to

- (a) Install and use the Software on a single computer (or in a single network, if your Software is designated as a network version). Customer may transfer the Software to another single computer (or network, if a network version), but the Software may never be installed on more than one computer (or more than one network, if a network version) at any one time.
